

From the Boulevard to the Slants, The Sensational History of Scandalous, Immoral and Weird Brands and the Application of 15 U.S.C. § 1052(a) Part 3: With the Supreme Court's approval to hear the lancu v. Brunetti case, the court has another opportunity to determine whether the USPTO's ban on "scandalous" and "immoral" trademarks violates the Frist Amendment. Mr. Meyers will explore the case history by which the definition of "immoral" has been determined, the differences between "immoral" and "scandalous" brands and evidence used to establish that a candidate brand may disparage and whom it may disparage, and whether the disparage provisions of the Act are invalid under the Free Speech amendment of the U.S. Constitution. He will lead a discussion and Q & A session as well following his presentation. In this continuation, Mr. Meyers will recap the decision and commentary from noted authorities as well as possible additional published decisions post 'Slants' reaction and action by the USPTO.
